Independent Practitioner's Review Engagement Report

To the Chief and Council of

Membertou Reserve Band Council

We have reviewed the accompanying Schedule of Honoraria, Salaries, Travel Expense and Other Remuneration Paid to Chief and Council and senior unelected officials of Membertou Reserve Band Council (the "Schedule") as at March 31, 2018. This schedule has been prepared by management based on the reporting requirements of Section 7.3 of the Department of Indigenous Services Canada's year end reporting handbook.

Management's responsibility for the financial statements

1. Basis of Accounting
